

Background

Movement controls are required to reduce the risk associated with movement of risk items between orchards and between regions, consistent with the NPMP objectives. Movement of any risk items that potentially constitute, harbour or contain kiwifruit vine material create a serious risk of spread of **biosecurity threats including Psa-V**. The risk associated with movement of plant material is considered to be high.

Scope

This protocol covers the following risk items:

- any kiwifruit wood for firewood;
- compost containing kiwifruit plant material;
- kiwifruit vines or prunings from an orchard;
- any kiwifruit vine or vine material removed from a home garden or non-commercial orchard; and
- all other plant material—not including budwood, rootstock or plants, seedlings and seeds for propagation. For these items refer [KVH Protocol: Budwood](#), and [KVH Protocol: Nursery Stock](#).

Requirements

- All kiwifruit plant material from a Psa-V positive orchard (or other site) **cannot** be moved off a Psa-V positive orchard (or other site) unless approval has been given by KVH.
- **Kiwifruit material is prohibited from sale or display as part of, or the whole, of any floral arrangement.**
- Any kiwifruit plant material must be disposed of as per [KVH Protocol: Disposal Options](#).
- Compost containing kiwifruit plant material must only be moved from KVH approved compost manufacturers. (Refer [KVH Protocol: Disposal Options](#).)
- Any plant material moved must be securely stored and handled in such a way that prevents dispersal, and fully covered during transport to another site.
