Psa status

In preparation for grafting season, KVH gets lots of queries around Psa status of orchards.

Plant material cannot be moved from a Psa positive to a Not Detected orchard. If a KPIN has not had a positive test result or KVH has not been contacted with confirmed Psa positive symptoms on the orchard, then that KPIN will be recorded as Not Detected in the KVH database.

Remember to remove unpicked fruit by 1 July

Growers are reminded that unpicked kiwifruit must be removed from vines by 1 July each year. If picking has been delayed through weather or labour shortage, please inform KVH of the delay and expected time the orchard will be picked.

KVH takes part in lab open day

The Plant Health and Environment Laboratory (PHEL) of the Ministry for Primary Industries (MPI) is New Zealand's national plant health reference laboratory responsible for identifying and confirming all suspect new plant pests and diseases, and invasive plants found in New Zealand.

Recently KVH was invited to a Government Industry Agreement (GIA)-partner open day at PHEL in Auckland, to meet the science team, and hear more about their biosecurity surveillance and incursion investigation role.

Tougher stink bug measures

In the wake of another successful stink bug season, enhancements to import rules are being considered that will make it harder for the invasive pest to establish in New Zealand.

Under proposed changes to the Biosecurity New Zealand import health standard for vehicles, machinery and parts, Poland will be added to the list of 37 risk countries. This will mean vehicle imports from Poland will need to undergo treatment or other approved measures before arriving in New Zealand.

Import suspension manages fruit fly risk



The Ministry for Primary Industries (MPI) has suspended imports of lychee and mango from Taiwan, after fruit fly larvae were found on fresh fruit at the border.

On Friday 18 June five larvae were detected on a consignment of vapour heat-treated (VHT) lychees from Taiwan and formally identified as Oriental Fruit Fly – a species of serious threat to the kiwifruit industry.
